### **REGULAR COUNCIL MEETING MINUTES**

February 21, 2018

#### **Public Hearing/2018-19 Budget**

President Burger called public hearing open at 6:30 p.m. One member of the public in attendance. No questions were asked with regards to the budget.

**Call to Order:** President Burger closed the public hearing at 7:00 p.m. and called the February meeting to order.

**County Commissioner:** no report.

#### **Kevin Hughes/Onkama School-Superintendent**

Presented the 2017 annual school report to the council. Many projects underway, new roof, heating and cooling system upgrades, heated stairs were made possible due to the bond passage. Steady enrollment with around 439 kids.

#### **Onkama Township Fire Dept./request**

Asked permission from the council to install a Dry Hydrant off of the village boat launch with no cost to the Village. After some discussion it was the consensus of the council to allow this

Trustee Schwing moved, Trustee Hudson supported to continue meeting the 3<sup>rd</sup> Wednesday of each month at 7p.m. for the 2018-19 fiscal year. M.C.

#### **COMMITTEE REPORTS**

**ZONING:** report from acting ZA Hendricks is on file with the clerk.

**PLANNING COMMISSION** – no report

**SEWER-**quarterly samples are done.

**STREETS:**

Still waiting for reimbursement for the repair of the storm drain on Spring St. from the contractor (working for Charter) who damaged the drain when installing internet cable. The following are possible street repair projects that are being investigated: 3<sup>rd</sup>. Street, North of Catholic Church, 3<sup>rd</sup> street south of Catholic Church, Spring Street- east of Zosel & 5<sup>th</sup> & Fairview. No decisions were made at this meeting. Council was asked to look at these streets for their input at the March meeting.

**PARKS AND THE FARR CENTER****Parks:**

Mary Reed gave report on the trails project and a watershed update. The village has been contacted again by the Lions' Club regarding the park pavilion project. We are waiting on drawings. Additional questions regarding an architect were also answered.

**Farr Center:** Trustee Schwing reported that trustee Miller has accepted the job of painting the offices and installing the carpeting in Farr Center. Schwing moved, Miller supported to raise the rental rates (for 100 persons) from \$135. To \$150. M.C. Franz opposed.

**CEMETERY:**

The draft cemetery policy is still being worked on.

**TOWNSHIP REPORT** – minutes on line.

**UNFINISHED BUSINESS:** None.

**NEW BUSINESS:**

---Ray Franz was sworn in (in January) as the new Village Council Trustee. He was also appointed to sit on the sewer committee.

--Recommendations (identifying existing and potential liability exposures) from recent Risk Control visit (MI Township Participating Plan) are being worked on.

--Alice Hendricks resigned from the council as of February 2. A replacement trustee is needed.

--Trustee Schwing is working on a mission statement. Draft statements will be available for the March meeting. She also would like the council to consider hiring another employee to help the maintenance man. After some discussion it was decided to have the personnel committee to look into this.
