The hearing was called to order by President Burger at 6:30 p.m.

The purpose of the hearing was to receive comments from the public on the proposed 2016-17 budget. No public in attendance, no questions.

President Burger closed the public hearing at 7:p.m. and called the February Council meeting to order.

PUBLIC COMMENT: County Commissioner Dontz gave a brief synopsis of the activities in the county.

APPROVAL OF MINUTES: Hendricks moved, Hudson supported to approve the minutes of the January 20, 2016 Council Meeting as presented. M/C.

TREASURER'S REPORT: Milasich moved, Drumm supported to accept the January 2016 Statement of Accounts as presented. M/C.

TREASURER'S REQUEST: Drumm moved, Miller supported to approve the amendments to the 2015-16 budget as requested. M/C. It was the consensus of the council to have the treasurer present needed amendments for the budget every 2 months.

BILLS / TRANSFERS: Bauer moved, Milasich supported to pay the bills and make the transfers. M/C.

Adoption 2016/17 Budget

The following resolutions were presented to the board:

RESOLUTION 2016-#2

Budget Adoption & Tax Levy

This resolution shall authorize the appropriation of the necessary funds for the governmental and administrative operations of the Village of Onekama for the 2016-17 fiscal year.

The Onekama Village Board does hereby resolve that the funds appropriated will be used for the various purposes specified in the presented proposed budget which include wage increases for the following: building maintenance person, clerk, treasurer, liquor enforcement person, and the zoning administrator.

The Onekama Village Board does further resolve to increase the General Fund millage by 1 mil and the Major St Fund millage by ½ mil in accordance with section 69.1 of the General Law Village Act of 1895 to

defray the general expenses and liabilities of the Village of Onekama for the 2016-17 fiscal year. This increases the current millage from 5.5 to 7.

Trustee Milasich moved and Trustee Miller supported to approve Resolution 2016#2 which adopts the proposed 2016-17 budget and increases the millage 1 ½ mils. M/C.

COMMITTEE REPORTS

ZONING – The Zoning Administrator's Report is on file with the clerk

PLANNING COMMISSION – several meetings have been held on the proposed Zoning Ordinance Amendments. A Plan. Comm meeting will be held Monday-February 22, 2016 at 1:p.m to approve the transcript proceedings of the February 12 public hearing.

CIP: Capital Improvement Program

Cecelia Huebner shared with the council the info she has gathered with regard to acquiring grants for the improvement to the Village main St. M/22. Talked to M/Dot TC office. She will be meeting with Patti O'Donald from M/Dot for grant writing info. The council gave Huebner permission to display a drawing of future street scape ideas for M-22 in the outer hall.

SEWER –With regard to the request last month for reclassification of sewer service from commercial to residential and a lower equivalent for the property, after some investigation by the President, he requests that that the lower of the rating not happen until the Council sees some evidence of change in the property. The council agreed.

STREETS – maintenance person Gronostalski doing a great job plowing the streets.

President Burger also reported that maintenance person Gronostalski and Clerk Hudson met with Mike Morin, a risk control rep associated with our insurance carrier to discuss the operations of the Village and to assist the Village and its services in reducing any existing and or potential liability exposures. Written recommendations will be forthcoming.

PARKS / FARR CENTER – Farr Friends using building weekly.

EXPLORE THE SHORES - waiting for last reimbursement check.

PLA- Diane Bess introduced herself as the new president of the PLA. She also read a letter thanking the council for allowing the Farr Friends program to meet weekly at the Farr Center.

WATERSHED – Mary Reed reported that the new Lake Management Report has been completed. Work continues on the construction of two rain gardens planned for behind Farr Center. They will work with the Portage Lake Garden Club and conservation district to show the public what constitutes a rain garden. The watershed will receive input from the Village Council with regard to the exact placement of said garden.

COMMUNITY PARKS AND RECREATION –The county wide plan was adopted.

CEMETERY – quiet.

TOWNSHIP REPORT – Public Hearing on the proposed sewer around the lake.
